3 (a) The objects to be pursued by the company on its incorporation are:

1. To promote, support, develop and advance education among students and youth in rural, semi-urban and urban areas by providing academic, vocational, technical and professional education and training.
2. To undertake, organize and conduct skill development programs, workshops, training sessions, certification courses, digital learning initiatives and capacity building programs aimed at enhancing employability, entrepreneurship and self-reliance among students.
3. To promote education in emerging and modern fields including information technology, digital literacy, artificial intelligence, communication skills, personality development and other life skill areas.
4. To establish, run, support or assist schools, training institutes, learning centres, libraries, digital education platforms, research centres and other educational institutions for the benefit of students and society at large.
5. To provide scholarships, fellowships, stipends, educational grants,

study materials, mentorship and career guidance to deserving and economically weaker students.

6. To promote public service activities by encouraging student participation in social welfare programs, community development initiatives, environmental protection activities, health awareness campaigns and nation-building activities.

7. To collaborate with government bodies, educational institutions, industry partners, skill development councils and other organizations for promoting education, skill development and public service initiatives.

8. To undertake research, surveys, awareness programs and policy advocacy in the field of education, skill development and social welfare for the betterment of society.

(b) *Matters which are necessary for furtherance of the objects specified in clause 3(a) are

1. To receive grants, donations, subscriptions, contributions, endowments and funds from government, non-government organizations, institutions or individuals for achieving the above objects.

2. To acquire, establish, maintain or manage infrastructure, movable and immovable properties, equipment and technology platforms necessary for carrying out the objects of the Company.

3. To do all such other lawful acts, deeds and things as are incidental or conducive to the attainment of the above objects.

4. To undertake and provide placement assistance services, career facilitation, recruitment support, internship coordination, and admission support services for educational institutions and students, as part of income generation activities of the organization, provided that such activities are incidental to and in furtherance

of the main objects of education, skill development and public service, and the income generated therefrom shall be applied solely towards the attainment of the Company's charitable objects.

the doing of all such other lawful things as considered necessary for the furtherance of the above objects:

Provided that the company shall not support with its funds, or endeavor to impose on, or procure to be observed by its members or others, any regulation or restriction which, as an object of the company, would make it a trade union.

5 (i) The profits, if any, or other income and property of the company, when-so-ever derived, shall be applied, solely for the promotion of its objects as set forth in this memorandum.

(ii) No portion of the profits, other income or property aforesaid shall be paid or transferred, directly or indirectly, by way of dividend, bonus or otherwise by way of profit, to persons who, at any time are, or have been, members of the company or to any one or more of them or to any persons claiming through any one or more of them.

(iii) No remuneration or other benefit in money or money's worth shall be given by the company to any of its members, whether officers or members of the company or not, except payment of out-of-pocket expenses, reasonable and proper interest on money lent, or reasonable and proper rent on premises let to the company.

(iv) Nothing in this clause shall prevent the payment by the company in good faith of prudent remuneration to any of its officers or servants (not being members) or to any other person (not being member), in return for any services actually rendered to the company.

(v) Nothing in these clauses (iii) and (iv) shall prevent the payment by the company in good faith of prudent remuneration to any of its members in return for any services (not being services of a kind which are required to be rendered by a member), actually rendered to the company

6 No alteration shall be made to this memorandum of association or to the articles of association of the company which are for the time being in force, unless the alteration has been previously submitted to and approved by the Registrar.

9 True accounts shall be kept of all sums of money received and expended by the company and the matters in respect of which such receipts and expenditure take place, and of the property, credits and liabilities of the company; and, subject to any reasonable restrictions as to the time and manner of inspecting the same that may be imposed in accordance with the regulations of the company for the time being in force, the accounts shall be open to the inspection of the members. Once at least in every year, the accounts of the company shall be examined, and the correctness of the balance-sheet and the income and expenditure account ascertained by one or more properly qualified auditor or auditors

10 If upon a winding up or dissolution of the company, there remains, after the satisfaction of all the debts and liabilities, any property whatsoever, the same shall not be distributed amongst the members of the company but shall be given or transferred to such other company having objects similar to the objects of this company, subject to such conditions as the Tribunal may impose, or may be sold and proceeds thereof credited to the Rehabilitation and Insolvency Fund formed under Section 269 of the Act.

11 The Company can be amalgamated only with another company registered under section 8 of the Act and having similar objects.


